General Terms of Use

The salsafor.me site is property of Digital Technology LTD, incorporated under the laws of the Republic of Bulgaria and providing services in the area of photo and video shooting, processing and montage of received materials.

- 1. The current General Terms are intended to regulate the relationship between Digital Technology and the website users on how to acquire and use the materials on the site.
- 2. Digital Technology has the right to change the design, form and technology services provided without prior notice to consumers about it.
- 3. Digital Technology has discretionary powers to grant only part of the services it offers or to stop all access to them to all or only certain users.
- 4. With confirmation of registration on salsafor.me, the user makes electronic statement in the sense of the law for electronic document and electronic signature, with which he/she declares that he/she is familiar with the current General Terms and the relationship between him/her and Digital Technology have the force of a treaty which must be respected.
- 5. By accepting these general conditions, the user agrees to receive unsolicited commercial communications under article 6 of the Law on electronic commerce.
- 6. Digital Technology does not collect personal data about the visitors of salsafor.me outside the technologically necessary identification information, which is automatically saved. This information is not used or provided to third parties except in cases provided by law and requested by competent state authorities.
- 7. All materials on this site, including photos, videos, clips, ads, articles and more are protected by copyright.
- 8. The materials published on the site can NOT be used, copied or quoted without written permission from the author.
- 9. All content / images / video / are intended for personal use.
- 10. If on any of the materials, an artist who was shot, does not want his photos to be available for download, he/she may declare it's desire to the shown contacts.
- 11. The use of materials for commercial needs may happen only after written contribution with the author for each particular case.
- 12. Obtaining the necessary documents authorizing the use of materials for commercial purposes happens after contact with the site administrator and specifying the details and conditions of use.
- 13. If the materials will be used commercially by a third party, i.e. not the person who was shot, a permission from the author is necessary as well as a permission by the person / people / who are on the photo or video material.

- 14. If the person who wishes to use the materials is a third party, who does not appear on them, then the administrator of the site shall connect with the people shot and will negotiate the conditions for the use of the materials in compliance with the requirements.
- 15. If as a result of failure to meet the conditions in p.11, p.12, p.13, p. 14 by the user to Digital Technology, the first shall be liable to pay compensation for damages to third parties, the user shall compensate Digital Technology entirely up to the amount paid by him and for all damages and lost profits suffered by Digital Technology.
- 16. Digital Technology is not responsible for incorrectly filled information, technical malfunctions or failures in the transmission environment.
- 17. With the exception of the personal galleries, all pictures and some videos are available for viewing by any visitor of the site without registration required.
- 18. Some of the materials and services are available for registered users only.
- 19. Registration is available for any user, but a valid e-mail is necessary for its confirmation.
- 20. Registration is on a separate computer. I.e. registration made on one computer can not be used on another. Difficulties associated with this condition shall be permitted after contact with the administrator of this site by providing an e-mail addresses and full description of the case.
- 21. Much of the videos and some services are available for registered users with status "member" only.
- 22. Status "member" is activated after paying the monthly fee, the amount of which depends on the period for which the status will be active.
- 25. After the expiry of the period, the status "member" is automatically deactivated if the subscription is not renewed in the meantime.
- 26. Digital Technology may change the General Terms at any time and shall notify customers through the site. Each entry with a username and password after the unveiled changes assumes that users have accepted them.
- 27. For all matters, not governed by the current General Terms, the active Bulgarian legislation is valid.
